ORDINANCE NO.2016-207

AN ORDINANCE approving the City of Joplin to execute Amendment No. 8 to the Professional Services Agreement with Deloitte Financial Advisory Services LLP to provide implementation and administrative activities, not to exceed Four Hundred Nineteen Thousand Dollars (\$419,000.00) and authorizing the Director of Planning, Development and Neighborhood Services to execute said Agreement; and containing an emergency clause.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JOPLIN, MISSOURI, as follows:

Section 1. That the City execute Amendment No. 8 to the Professional Services Agreement for Professional Administrative Consulting Services between the City of Joplin and Deloitte Financial Advisory Services LLP to provide implementation and administrative activities, not to exceed Four Hundred Nineteen Thousand Dollars (\$419,000.00), for Community Development Block Grant – Disaster Recovery (CDBG-DR) funding received by the City.

Section 2. That the Planning, Development and Neighborhood Services Director of the City of Joplin, Missouri, is hereby authorized to execute said Agreement for and on behalf of the City of Joplin.


Section 3. This ordinance is an emergency within the means of Section 2.12 (6) in that said ordinance provides for public improvements and is considered an emergency by the Council and as such shall become effective immediately upon this passage as provided by the Home Rule Charter for the City of Joplin. Specifically, this ordinance approves consulting work on public infrastructure and public facilities projects to begin immediately.
